You may recall that Ray Whitney got a letter published in the Daily Mirror as a counter balance to its campaign of scare stories on the NHS. The Mirror responded by publishing an editorial headed "You're a liar, Mr. Whitney". This is at Flag A.

Ray Whitney has now asked the Law Officers (as he is bound to do by Questions of Procedure for Ministers) about the possibility of an action for defamation.

A note by Bernard is at Flag B. Ministers are not required under Questions of Procedure to consult you before proceeding and we should obviously have to tread very carefully when a Minister feels, as in this case, that the press has over-stepped the mark of legitimate comment. If you wished, however, we could indicate informally to Norman Fowler's office that you hope that the Secretary of State will keep a close eye on the situation and ensure that an action against the Daily Mirror was taken only after the most careful consideration by Mr. Whitney and his advisers. The point is surely that the kind of scurrilous campaign being waged by the Daily Mirror has to be fought by political means and not by resorting to the courts. As Bernard has said politicians would seldom be out of the courts if they issued writs every time they are accused of not telling the truth.

Would you like us to give an informal indication to Norman Fowler's office as I have suggested?

MR FLESHER MR WHITNEY - DAILY MIRROR You sought my advice on Mr Whitney's proposal to: sue the Mirror Group; and possibly to i. refer the Mirror to the Press Council. My first point is that I think Mr Whitney should proceed with caution and in consultation with his Secretary of State. It is not clear to me that the DHSS has pursued the Mirror's campaign with consistent vigour, and you will recall that we had to urge them to set the facts on Parliamentary record - an action calculated, I believe, to put them in a strong position in relation to all critics and campaigners. Second, Questions of Procedure for Ministers (Para 24)

Second, Questions of Procedure for Ministers (Para 24) requires Ministers to consult the Law Officers before consulting their own solicitors "in order to allow the law officers to express a view on the handling of the case so far as the public interest is concerned or, if necessary, to take charge of the proceedings from the outset".

Para 122 is clear that Ministers who wish to make a complaint against a journalist, or a particular section of the media, to the Press Council "must have the authority of the Prime Minister". The nature of the complaint and the case for referring it should be set out in a letter to the Chief Press Secretary, copied to the Secretary of the Cabinet.

However, this does not affect my advice. I believe Ministers should think very carefully about legal proceedings, except in the most outrageous circumstances. A great many writs would be issued if Ministers sued every time they were called a liar or their veracity was impugned.

I am less hostile to a reference to the Press Council for I think Mr Whitney has a good case against the Mirror's objectivity and balance on the evidence available. It is, however, the case that we cannot rely on a favourable Press Council finding. Much would, of course, depend on the precise nature of the complaint.

The Parliamentary Under Secretary (Health) has requested that I write, pursuant to paragraph 24 of "Questions of Procedure for Ministers", to seek the view of the Law Officers in connection with an action for defamation which he is contemplating taking against the Daily Mirror Group of Newspapers in respect of an editorial which appeared on 10th July (flag A in the bundle) entitled "You're a liar Mr Whitney". In accordance with the advice in paragraph 24 he has not yet sought advice from his own solicitors.

Over the past few months, the <u>Daily Mirror</u> has run a number of NHS "scandal" stories alleging in each case that these are further examples of the effect of NHS cuts. In each case, investigation has shown the stories to be completely untrue or very seriously distorted.

A summary of the main allegations, about incidents at the Middlesex, Maudsley, Addenbrookes and St George's hospitals, and of the true position, is set out at flag B of the bundle; the press cuttings relating to those, and other, cases are set out in flag C. At flag D are the unpublished responses respectively of the Middlesex (press statement), and consultants at the Maudsley (letter to Mirror of 9th July), and at Addenbrookes (letter to Mirror of 15th May).

At flag E is correspondence which has passed between PS(H) and the Daily Mirror Group, beginning with a letter of 14th March in which Mr Whitney pressed for the true facts concerning the case at the Middlesex to be published, and culminating

in his letter which was published on 11th July and subsequent correspondence. At no time since 10th July has the Mirror retracted its allegation of 19th July (flag A) that Mr Whitney was "a liar".

Reference is made in the correspondence to Mr Whitney's interview on TV am on 9th April; a transcript is enclosed at flag F. It is thought that the Mirror comment of 10th July may have been stimulated by Mr Whitney's reference to one of the allegations in an adjournment debate on 1st July (extract from Hansard at flag G). I should add that consideration is being given as to whether reference should be made to the Press Council concerning the Mirror's campaign.

In the light of these events, my Minister would welcome any view the Law Officers' may have on the handling of the matter so far as the public interest is concerned, and to know whether they would be prepared, as envisaged in "Questions of Procedure", to take charge of any proceedings.

Guy's Hospital

Children's Cardiac Unit

Line to Take

This is another example of a misleading and melodramatic press atory which paints a false picture of the standard of health care in a London teaching hospital and is liable to cause unnecessary alarm to the parents of children awaiting treatment.

First and foremost, the Children's Cardiac Unit is not faced with cut backs. It has recently in fact expanded from two beds to four. The only delay in making it fully operational is the time it is taking to recruit the right calibre of paediatric nurses to staff the two extra beds. It is not, repeat not, a question of money. Meanwhile all emergency cases are being covered.

The temporary closure of 8 of Guy's 11 operating theatres has been brought about by the need to upgrade the air conditioning system. All emergency cases will be covered in the remaining 3 theatres. By early September all 11 theatres will be in full working order and even better able to provide health care facilities for patients.

2 ground Note

It is totally false to claim, as the article does in its last but three paragraph on page two, that "the hospital can only staff two intensive care beds". Bed numbers in the children's cardiac unit have recently been doubled from 2 to 4. However paediatric nurses of the right calibre have not yet been recruited to staff these two extra beds. Guy's has the funds to recruit the additional staff, it is not a question of money, but, like other hospitals, it is finding it difficult at present to attract agency or NHS nurses in this particular specialism.

It is possible that the two staffed beds in the Unit were occupied in June when Hayley's operation was postponed. This delay was emphatically not due to cost cutting. No child will be asked to wait for an operation if by doing so their health will suffer. This applies to 'hole in the heart' children for whom a delayed operation will not be critical. Emergency cases must always take priority.

Temporary Closure of Operating Theatres

In June Legionella was discovered in the air conditioning system feeding 8 of the 11 operating theatres at Guy's. This system had to be replaced. Work on replacement will take over six weeks but by careful planning closure of the theatres will last for six weeks from 4 August.

Meanwhile, the remaining three theatres, fed by a separate air conditioning system, will be covering emergency cases.

JUNIOR Health Minister Ray Whitney winges that things aren't rally too bad in our hospi-tals. Tory chaiman Norman Tebbit whines about "scurrilous" Daily Mirror reporting on the Health Service Crisis.

Twenty-month old Hay-ley Knight must have the operation to mend a hole in her heart and repair

an artery before she is two years old.

But Guy's Hospital in London, where she is a patient, is closed to all routine surgery for the next six weeks.

New Haley's anxious parents are trying to raise £5,500 to have the operation done privately. Her 25-year-old father Stephen, from Woolwich, South East London, said: "Hayley keeps having blue spells where she can't breathe and has to be rushed into any legal

"The doctors toll they will consider her the operation when it respen in September. I by then there will be many children on waiting list that we frightened she might get it done.

"She needs the opera-tion as soon as possible and if it means paying that is what we will de."

Hayley should have had the operation in April but went down with a bug.

She was due to be read-mitted to Guy's in June. But all children's heart operations — including emergencies — were stopped for two weeks because of cath cuts and a shortage of nurses.

The hospital can only afford to staff two intensive-care beds and both were occupied.

New Guy's is closing to all but emergency for six weeks while work is done on the air conditioning.

Burgeon Max Rendell, clinical superintendent at Guy's, said: "Only three operating theatres will be in action so we will only do emergency surgery.

"Stopping admissions

"Stopping admissions will save money, but that is not the primary purpose."
