- 1. AN AFP REPORT DATED 4 MAY, WHICH DOES NOT APPEAR TO HAVE BEEN REPRODUCED IN ANY FRENCH PAPERS, SAID THAT THE LATIN AMERICAN HEADS OF MISSION IN PARIS, IN AN AGREED COMMUNIQUE PUBLISHED ON TUESDAY
- (A) A CALL' IIFOR THE IMMEDIATE CESSATION OF HOSTILITIES, IN CONFORMITY WITH UN RESOLUTION 502 AND THE OAS RESOLUTION!!
- (C) THE JUDGMENT THAT A SOLUTION TO THE CONFLICT !! CAN ONLY BE

IN SPEAKING TO AFP ABOUT THE HEADS OF MISSION MEETING THE ARGENTINE AMBASSADOR IS REPORTED TO HAVE SAID THAT ILLATIN AMERICAN UNANIMITY, REALISED FOR THE FIRST TIME, DEMONSTRATES THE MORAL SUPERIORITY OF ARGENTINA IN THIS CONFLICT!!.

2. THE CHILEAN EMBASSY IN PARIS, IN REPLY TO OUR QUESTIONS, CONFIRMED THAT THERE HAD BEEN A MEETING ON 3 MAY. THIS WAS THE REGULAR MEETING OF LATIN AMERICAN HEADS OF MISSION UNDER THEIR CURRENT CHAIRMAN (BRAZIL) WHICH TAKES PLACE ON THE FIRST MONDAY OF EVERY THE ALSO CONFIRMED THAT A STATEMENT WAS AGREED ON THE LINES REPORTED B AFP, BUT MAINTAINED THAT COLOMBIA AND CHILE HAD FIRMLY STATED THAT THEIR SUPPORT FOR THE ARGENTINE CLAIM TO THE FALKLANDS

OF RESSION, WHICH THEY DID NOT SUPPORT. IN PRESENTING THE UNIQUE TO THE PRESS, THE ARGENTINE AMEASSADOR HAD USURPED THE POINTION OF THE REGULAR SECRETARIAT OF THE LATIN AMERICAN GROUP (CURRENTLY HELD BY THE MEXICAN COUNSELLOR) AND DISTORTED THE SIGNIFICANCE OF THE MEETING. THE CHILEAN EMBASSY HAD NOTED WITH RELIEF THAT THE REPORT HAD NOT BEEN TAKEN UP BY THE FRENCH PRESS AND HOPED THAT IT WOULD NOT IMPAIR GOOD RELATIONS BETWEEN CHILE AND BEITAIN.
