1. I HAVE NATURALLY DISCUSSED YOUR AAA/19 (2002) WITH CTG

317.0 WHO AGREES WITH THIS SIGNAL.

2. PRESENCE ON WEST FALKLANDS. IT IS ALREADY INDISPUTABLE THAT THE ENEMY HAS CONTROL OVER EACH OF THE MAIN SETTLEMENTS. TO TAKE ON EITHER SERIOUSLY, OR TO MAINTAIN PRESENCE OURSELVES, COULD ONLY DIVERT SOME OF OUR SLENDER RESOURCES (SEE MY ADA/ 19N 0301002) FROM THE MAIN AIM. FOR HIM TO LAND FURTHER TROOPS BY PARACHUTE OR EVEN BY SOME DESPARATE LANDING OPERATION IN EITHER EAST OR WEST FALKLAND WOULD ACHIEVE NOTHING IN MILITARY TERMS. FROM POLITICAL OR NEGOTIATING POINT OF VIEW I QUITE UNDERSTAND THAT AN INCREASE OF ARGENTINE PRESENCE IN WEST FALKLAND IS UNDESTRABLE. HOWEVER TO COUNTER THIS, I COULD INSERT A TOKEN FORCE, UNOPPOSED TO QUOTE FLY THE FLAG UNQUOTE IN WEST FALKLAND IF THIS BECOMES NECESSARY FOR NEGOTIATING PURPOSES. WITH BLINDFIRE RAPIER WE SHOULD BE PRETTY EFFECTIVE PROVIDED WE HAVE WARNING MUCH OF WHICH CAN ONLY BE PROVIDED BY ESCORTS. MAINTENANCE STOCKS ARE BEING STACKED TO PROVIDE MINIMAL TARGETS. PORT SAN CARLOS AIRFIELD IS NOW OPERATING AND SHOULD FURTHER IMPROVE OUR AIR DEFENCE AS WELL AS GROUND ATTACK CAPABILITY BY OFFERING TURNROUND OR EVEN ALERT FACILITIES TO SHAR AND GRS.

5. GENERAL. IT WOULD SEEM TO ME THAT THE MOST ATTRACTIVE ARG
OPTION WOULD BE TO MAKE AN ALL OUT AIR, AND PERHAPS NAVAL
EFFORT AGAINST OUR FORCES ON AND AROUND EAST FALKLAND WITH A
VIEW TO DRAWING THE MAIN BATTLE GROUP NEAR ENOUGH FOR A SUCCESSFUL
STRIKE USING EXOCET. THE CORNERING OF A SUBSTANTIAL SAG OR
CONVOY WHERE A4/MIRAGE COULD TAKE OUT SEVERAL SHIPS MIGHT DO.
I BELIEVE THAT CTG 317.0 AND I CAN WITHSTAND SUCH AN EFFORT
PROVIDED THAT WE TAKE SENSIBLE PRECAUTIONS IN SHIPPING
