ON 2 JUNE, RODRIGUEZ HEAD OF CHILEAN AIR FORCE INTELLIGENCE 012120Z JUNE TO MODUK). RODRIGUEZ PRODUCED A NUMBER OF TELEGRAMS WHICH HE CLAIMED CONTAINED THE FIRST INKLINGS HE HAD HAD OF THIS EXERCISE, BUT IT IS ODD THAT AS AIR FORCE-CHIEF OF INTELLIGENCE HE SHOULD NOT HAVE BEEN INFORMED OF AN EXERCISE WHICH, INVOLVING THE RAPID DEPLOYMENT OF SO MANY MEN, WOULD NECESSARILY HAVE CALLED B. ONE OF HOWARDIS-MEN WHO HAD BEEN IN THE PUNTA ARENAS AREA SINGE 31 MAY AND HAD BEEN ABLE TO FLY EXTENSIVELY OVER THE AREA REPORTED ON 2 JUNE THAT HE HAD SEEN NO SIGN OF UNUSUAL MILITARY ACTIVITY. RODRIGUEZ HAD EARLIER RAISED OBSTACLES TO HIS VISIT AND C. ON 3 JUNE, RODRIGUEZ ABRUPTLY CHANGED HIS LINE OF THE PREVIOUS DAY AND RECOMMENDED THE SWIFT DEPARTURE FROM CHILE OF THE WHOLE D. ON 4 JUNE, RODRIGUEZ WAS IN SUDDEN HASTE TO WITHDRAW THE RAF HERCULES FROM CHILE, AGAIN IN CONTRADICTION OF HIS LINE UP TO THE PREVIOUS DAY. THE RAF CREW HAD EARLIER BEEN PREVENTED FROM
