VISIT OF PRIME MINISTER:

1. ARRIVAL PROCEDURE AT SEOUL (KIMPO) AIRPORT ON 2 MAY.

2. FORMAT AS PER PLAN ISSUED WITH LONDON ADMINISTRATIVE ARRANGEMENTS EXCEPT THAT KOREAN DIGNITARIES, THE ACTING DEAN OF THE DIPLOMATIC CORPS AND EMBASSY STAFF WILL BE ON RIGHT SIDE OF PRIME MINISTER'S ROUTE. THERE WILL ALSO BE A PRESS AREA.

3. CHIEF OF PROTOCOL AND HM AMBASSADOR WILL BOARD AIRCRAFT TO GREET BRITISH PRIME MINISTER. MRS THATCHER AND SENIOR OFFICIALS THEN LEAVE BY FORWARD FRONT DOOR. KOREAN PRIME MINISTER STANDS AT BRIDGE. BOUQUET WILL THEN BE PRESENTED. THE TWO PRIME MINISTERS WALK PAST GUARD OF HONOUR. KOREAN DIGNITARIES AND DEAN ARE PRESENTED TO BRITISH PRIME MINISTER BY KOREAN PRIME MINISTER: HM AMBASSADOR WILL INTRODUCE STAFF.

 (+) SECRETARY-GENERAL TO THE PRESIDENT OF THE DJP
 (+) CHAIRMAN, JOINT CHIEFS OF STAFF
 VICE FOREIGN MINISTER
 VICE MINISTER OF GOVERNMENT AND ADMINISTRATION
 SECRETARY-GENERAL TO THE PRIME MINISTER
 PRINCIPAL SECRETARY TO THE PRIME MINISTER
 KOREAN AMBASSADOR TO THE UK PLUS ONE OR TWO OTHER OFFICIALS (N.B: THOSE MARKED (+) ACCOMPANIED THE PRESIDENT DURING HIS RECENT VISIT TO LONDON)

6. PRESS STATEMENT WILL BE ISSUED TO JOURNALISTS UNDER EMBARGO.
STATEMENT WILL NOT BE MADE ORALLY.

7. MEANWHILE REMAINDER OF UK PARTY (EXCLUDING M SAWER AND 2 R M POLICE) PLUS PRESS PROCEED VIA STAIRS TO CARS AS NUMBERED BELOW, WHICH WILL BE SITUATED OUTSIDE BUILDING. COULD ONE RMP ASSIST MRS RYDER WITH UPLIFT OF PRIME MINISTER'S LUGGAGE TO BOOT OF V.I.P CAR (REG NO 111) AND THEN RETURN TO VC10 TO ASSIST WITH HOLD BAGGAGE. GRATEFUL IF MISS BOWERS COULD HAND OVER TO MISS NOBLE PASSPORTS OF UK OFFICIALS IN ONE ENVELOPE PLUS PRESS PASSPORTS IN ANOTHER ENVELOPE.

8. EMBASSY VAN 7, PLUS EMBASSY LAND ROVER 8 AND TWO BAGGAGE VEHICLES WILL BE WAITING ON TARMAC. VAN 7 WILL BE BROUGHT TO CENTRE STEPS.
