1. I CONVEYED A SUITABLE MESSAGE TO HAIG ABOUT YOUR REACTION TO HIS, (THE TEXT OF WHICH WAS IN FCO TELNO 1044 TO WASHINGTON).
2. HAIG WAS GLAD TO HEAR YOUR PROVISIONAL REACTION.
3. HAIG IS OFF TO THE MID WEST TODAY TO MAKE A SPEECH BUT WILL BE RETURNING TOMORROW TO TAKE PART IN THE OAS DEBATE. HE HOPES BEFORE THEN THAT YOU WILL LET HIM HAVE SOME SORT OF REACTION TO HIS IDEAS AS THIS WILL HELP HIM TO SHAPE THE LINE HE TAKES AT THE RIO TREATY MEETING.
4. I SAID THAT THE NEW SECURITY COUNCIL RESOLUTION, WITH THE REQUEST OF THE SECRETARY GENERAL TO ENGAGE IN NEW NEGOTIATIONS, SHOULD HELP HAIG TO COUNTER MOVES AT THE OAS MEETING FOR IMMEDIATE ACTION. HE AGREED THAT HIS WOULD BE MOST USEFUL.
5. HAIG EXPRESSED GREAT REGRET AT THE LEAK ABOUT HIS MESSAGE TO YOU WHICH, HE REALISED, WOULD NOT HELP HIM OR YOU IN LONDON.
